on the draft “Regulations of the Social Consultation of the City of Jelenia Góra” and the draft “Plan of cooperation of the City Hall of Jelenia Góra with stakeholders”, conducted from 5 - 20 December 2022.

Jelenia Góra, December 2022

1. PRELIMINARY INFORMATION

Public consultations of the draft “Regulations for Public Consultation of the City of Jelenia Góra” and the draft “Plan for Cooperation of the City Hall of Jelenia Góra with Stakeholders”, were conducted from December 5 to 20, 2022. During this period, comments and proposals could be submitted to the draft of both documents.

Information about the planned start of consultations on the above documents was posted on November 25, 2022, on the project website www.rozwojlokalny.jeleniagora.pl and on the city website www.jeleniagora.pl, along with a redirect to the project website. In addition, on December 28, 2022, information about the planned start of consultations was posted in the Public Information Bulletin under the tab Public Consultation.

The consultations were carried out with the use of electronic consultation cards, through which residents and other stakeholders of the city, after reading the drafts of the “Rules of Social Consultation of the City of Jelenia Gora” and “Plan of Cooperation of the City Council of Jelenia Gora with Stakeholders” posted on the site, could submit their comments and suggestions on changes to the provisions of the documents mentioned above.

The primary purpose of the consultations was to collect comments and suggestions for changes to the projects and, as a result, to develop documents that are as close as possible to social expectations.

The City Development Department of the Jelenia Góra City Hall organised the consultation.

II. SUBMITTED COMMENTS – summary

57 people participated in the consultations (considering the votes of participants who did not provide their personal data, entering only their first name in the name field - 61 people).

In relation to the provisions of the draft “Rules of Social Consultation of the City of Jelenia Gora”, 6 comments were submitted, while to the provisions of the draft “Plan of cooperation of the Jelenia Gora City Hall with stakeholders”, 0 comments.
